

Rules for a charity auction

organized as part of a public fund-raising initiative for Daria Kukuła to cover the costs of rehabilitation, treatment, medical aids purchase and facilities for everyday use at home.



§ 1

Auction

1. These rules set up and define the principles for a charity auction organized as part of a public fund-raising initiative for Daria Kukuła to cover the costs of rehabilitation, treatment, medical aids purchase and facilities for everyday use at home.
2. Permit for this fund raising initiative was awarded by the Ministry of Administration and Digitization on November 12, 2012, decision no. 90/2012 (ref. no.: DAP-ZZP-632-1-336/12/AT).
3. The auction is organized by Our Children Foundation seated in Dąbrowa Górnicza, al. Piłsudskiego 92, 41-308 Dąbrowa Górnicza, KRS (registration no.): 0000377619, NIP (taxpayer's ID): 629-24-52-455, hereinafter referred to as the Foundation.
4. The auction is won by a bidder who, within the defined period and following these Rules, submits the highest bid.
5. The object of the auction is the original Paralympic Torch carried by Filip Kuźniak during the Paralympic Relay on August 29, 2012.
6. The auction is organized via electronic mail from 17.12.2012 to 24.12.2012.

§ 2

Starting price

1. Starting price will be expressed in euro (EUR) and announced to the public by the Charity Chapter of the Foundation at the Foundation's website: www.fundacja-naszedzieci.pl on December 14, 2012.
2. Starting price, subject to clause 3, will be the sum of all the funds collected from November 26 to December 13:
 - in the Foundation's bank account in **EUR**, account no.

61 1050 0086 1000 0090 3014 3102 (IBAN no. for foreign payments in **EUR: PL 61 1050 0086 1000 0090 3014 3102** **Swift: INGBPLPW**) and

- the sum of payments made to the Foundation's bank account in **PLN no. 63 1050 0086 1000 0090 3014 2096** (IBAN no. for foreign payments in **PLN: PL 63 1050 0086 1000 0090 3014 2096** **Swift: INGBPLPW**), and all donations made to money boxes put up in buildings upon the consent of their owners or users, converted into EUR based on the average exchange rate quoted by the National Bank of Poland on December 13, 2012.
3. The starting price may not be lower than the minimum price i.e. PLN 1046, 42, following conversion to EUR based on an average exchange rate quoted by the National Bank of Poland on December 13, 2012.

§ 3

Auction procedures

1. Any natural person of age with full legal capacity, as well as a legal person or an organizational unit without a legal personality may participate in the auction.
2. Payments are to be made in EUR.
3. Bids are to be e-mailed to: FundacjaNaszeDzieci@arcelormittal.com, and should indicate amount and the name of a company and/or name and surname of the bidder, address of the registered seat/residential address and telephone number. Bids with incomplete information will not be accepted. Bids might be subject to verification by employees of Our Children Foundation.
4. The organizer will, at least once a day, publish the current price of the auctioned object and the name of the company/bidder, whose bid was the highest at the time of update, at www.fundacja-naszedzieci.pl. Bidder may reserve a right to remain anonymous.
5. Should at least two bidders make the same bid, the one that was made earlier has priority (the time when an e-mail is received on the organizer's account is decisive).
6. A person, whose bid is the highest at the closing of the auction, will become the owner of the auctioned object provided that they transfer the declared amount for the auctioned object to the Foundation's account.
7. Auction results will be published at the Foundation's website: www.fundacja-naszedzieci.pl, including the winning bid in EUR and its equivalent in PLN. Conversion will be made based on average exchange rate quoted by the National Bank of Poland on December 24, 2012. Auction results are binding and final.

8. The winning bidder is obligated to settle the declared amount by the final deadline of January 4, 2013. Payment should be made to the Foundation's account:
 - in EUR to the account no. 61 1050 0086 1000 0090 3014 3102 (IBAN no. for foreign payments in **EUR**: PL 61 1050 0086 1000 0090 3014 3102 Swift: INGBPLPW)
 - or
 - in PLN to the account no.: 63 1050 0086 1000 0090 3014 2096 (IBAN no. for foreign payments in **PLN**: PL 63 1050 0086 1000 0090 3014 2096 Swift: INGBPLPW).
9. Receipt should bear a note "payment for the Paralympic torch", and its copy should be immediately e-mailed to: FundacjaNaszeDzieci@arcelormittal.com
10. Participant of the Auction agrees to have their name/name of the company published at the Foundation's website: www.fundacja-naszedzieci.pl and in other mass media. Auction participant may request to remain anonymous by sending a written statement to the Foundation's address.
11. Winning bidder undertakes to fulfill all formalities included in the bid, and in particular to transfer the bid amount to the bank account indicated in the rules by the deadline set.
12. Each Auction participant may make an unlimited number of bids.
13. The auctioned object will be handed over to the winning bidder on a date agreed by the parties concerned, however not earlier than seven days from the day on which the payment for the auctioned object is credited to the Foundation's account.

§ 4

Claims

1. All disputable issues arising during the Auction should be reported by e-mail during the Auction period.
2. Claims will be solved on a regular basis by the Chairman of the Board of Directors of Our Children Foundation.
3. Decisions made by the Foundation's BOD Chairman are final.
4. Doubts and claims filed after the closing of the Auction will not be taken into account.

§ 5**Personal data**

1. Personal data concerning Auction participants will be processed as per the Act of August 29, 1997 on personal data protection (Journal of Laws of 2002, No. 101, item 926). Personal data is provided voluntarily, however to participate in the Auction it is necessary to provide data in a scope defined by these Rules.
2. Personal data received by Auction participants as per these Rules will be kept in a database. Personal data will be processed for purposes related to the organization of this Auction. The provision of personal data is voluntary. Each participant has a right to view their personal data and correct it.
3. Personal data may also be processed if it is necessary to fulfill legally justified aims of the data administrator.

§ 6**Final provisions**

1. All costs related to participation in the Auction are borne by the participant.
2. Participation in the Auction equals the acceptance of these Rules.
3. Binding interpretation of these Rules is provided by Our Children Foundation.

5. Our Children Foundation reserves itself a right to amend the Rules, and to discontinue the organization of the Auction for technical reasons.
